01. This approval order for Block Grant is subject to stipulation under paragraph (15) of Orissa (Non-Colleges, Jr. Colleges & Higher Secondary Schools) G Order-2008.
02. The list of teaching & non-teaching employees in whom favour Block Grant is released based on the proposal submitted by the G.B. of the concerned college and verified at the level of Nodal Team of Govt. Science College Chhatrapur & scrutinized in this Directorate level.
03. If required, on receipt of any allegation regarding incorrect/ concealed information, the Block Grant released in this order in favour of the employee concerned shall be withheld until further clearance from Director, Higher Education, Orissa/ Govt. in Higher Education Department.
04. The amount required for payment of current Block Grant shall be met out from the budget provision of the current financial year 2011-12. Arrear claims as admissible in favour of incumbent will be released, subject to provision under Section-7(C) of the Orissa Education Act, 1969.
05. An undertaking in shape of affidavit is to be furnished by the teaching and non-teaching of the college that he/she will refund the amount received/ to be received by him/her in shape of Block Grant, if subsequently it is noticed that on the basis of any fraudulent means or suppression of facts the post in favour of the employee who is otherwise ineligible and has been approved by Govt. beyond the prescribed provision in the rule. The institutions and teaching & non-teaching employees will be liable for criminal prosecution as per law. The same amount if not refunded in time will be recovered from the employee of the institution under O.P.D.R. Act. The aforesaid affidavit / undertaking shall be submitted at the time of submission of bills of concerned Block Grant employee in
